Struggles and strikes of Iranian workers continue to spread!

The capitalist regime of *Iran has* not enjoyed its existence peacefully, during the past 41 years, because there has not been a day without protests or strikes. Due to several social uprisings, the overthrowing of the ruling exploiters has become more obvious. This round of strikes and protests, whose flag bearers are the Haft Tappeh Sugarcane workers, by making claims, and identifying their demands, they have raised the voice of the whole worker's movement in Iran. The strikes of over two months, by the Haft Tappeh workers demonstrate the demands of the entire worker movements and most of the people. This has displayed an alternative working- class option in Iranian society. The government, its large and small supporters, the thieves, and the embezzlers of the capital, are all terrified by the

workers' strikes and protests. In recent weeks, the workers' strikes have been expanded, and other sections of the workers movements, have raised and shouted their demands and disrupted the production cycle in Iran. The right-wings organizations and the exhausted opposition, as well as their affiliated media and the propaganda tools of the regime, have tried to censor the strikes of the Haft Tappeh workers and other Companies' workers as well.

MP says strike is over, but the reality is something else!

Haft Tappeh workers have not been on strike only for two months of wages; they have not even been on strike for four months of wages. Our demand is truly clear:

Immediate dismissal of the private sector and governmentalization of the company with full supervision of the workers or transfer of 100% ownership of the company to the workers of Haft Tappeh, return to work of dismissals and immediate payment of all arrears and trial of all government accomplices and conviction of Asadbeigi-Rostami (two managers)!

Latest news: Strikes of Haft Tappeh workers were suspended.

The Haft Tappeh Sugar cane workers syndicate warned in its next statement: "If the government and government institutions do not surrender within 15 days on the basis of the commitment made to the workers' demands, the strike of the sugarcane workers of Haft Hill will enter a new phase!"

Why do not we want privatization?

We should remind ourselves why we are highly against the privatization of Haft Tappeh? What is our problem with the private sector? Why does the private sector come to Haft Tappeh at all? Why does the government turn mines, factories, hospitals, and universities to the private sector? We realized the answers to these questions in Haft Tappeh with our own lives. The most important

thing for private sector is only profits. Therefore, when the privatization occurs, first expels many workers. Reduces wages and benefits. On the other hand, the government, by enacting the anti-worker law, allows private sector to ruin the workers' lives. In this manner the government helps and protects the progovernment class to gain power and wealth. Even when the country is in chaotic situations, Asadbegi and his diehard allies are relieved that they can delay wages and invest our money elsewhere. This is the dirty nature of the private sector. Continuation of Meter Manufacturing's workers' protests regarding their jobs and livelihood uncertainties and the empty promises of the management in front of Ghazvin Provincial Offices

On Tuesday August 4th, workers of the Meter Manufacturing gathered in front of the Ghazvin Provincial Offices in continuation of their protest for their job and livelihood uncertainties and the empty promises of the management.

Workers told the reporter present that the 26 months of their arrears, around \$150,000, were supposed to be paid by the selling of the "Niroo Color" shares that belonged to the Meter Manufacturing. This resolution had already been signed by the management in the Provincial Office with workers present.

Protesting workers added: unfortunately, in spite of signed resolution, the management has sold those shares around only \$120,000 and instead of depositing this amount into workers' account in the Judicial Office they have deposited into government treasury and out of the reach of the workers. They said that after this broken promise, they will continue their protest gatherings every few days.

Widespread strike by workers employed in projects is continuing forcefully in its fourth day

Increasingly more centres are joining this strike:

- Petrol-Palayesh which started the strike with its 800 workers has resolutely stood up and completely shut down the company.
- Ortho Part Company, Bagheri Contractors
- Isfahan Refinery
- Motavari Contractors, phase 14
- MAPNA Boiler combined cycle power station
- Tabriz combined power station (welders and fitters)
- Contractors group of Khuzestan Arya Negin, NGL
- Jafir Refinery in Ahwaz
- Tombak phase 13
- Ghaysari Contractors, Sangan Steel, Kooshan Steel Company
- Sabalan Petrochemical
- Tehran's Roodshoor power station
- Parse Jonubi phase 14 was shut down by the worker's will

Most of the workers are planning to go home and some are waiting in their dormitories hoping for the victory. Workers are resolute about the wages they have demanded. As an example, they have refused the Motavari Contractors offer of \$700 monthly wage for the fitters and unanimously declared that they "would not accept anything below \$800 plus annual bonus and benefits."

+ The first victory of the campaign gained, and the management accepted all demands of the campaign:

In Iranshahr power station, when workers after two days of strike were going to leave the workshop, the management declared that it has accepted all of their demands. The welders will sign the contracts with \$1,050 monthly wages as the base.

Protest of the Oil Refinery Workers in South Pars,
Phase 22 and 24 in Kanegan city
because of low wages, no job security
and not paying the wages on time

These workers protested because of low wages, no job security and not paying on time the wages. On August 3. They explained that there is no monitoring on the function of the company. They protested for low wages and told the reporter that their wages are injustice. "Since our job is hard, we get exceptionally low wages in will be paid with a lot of delays. Besides, we do not have any job security and hope for future, because we could lose our job in every moment."

The South Pars oil refinery workers criticized that their work is not covered by Labour law in this region. They said: "Nobody supports us, and we are working without any covering by Labour law. We would like that the authorities listen our voice through our gathering."

Strike and gathering the workers of Phase 2 Refinery Oil Abadan in protest for getting their wages on time

On August 1. And 2. these workers didn't work anymore and joined to the strike and protested because they weren't paid on time.

On August 3. Special Governor of Abadan told that the authorities were negotiating for solving the problem of the workers and he will return with good news.

Strikes and gatherings of hundreds of Razy Mahshare Petrochemical to protest low wages, discriminations in delivering worker's needs and firing of a worker colleague

On Tuesday, August 16th, more than 600 workers of Razi Mahshare Petrochemical stopped work and assembled to protest low wages, discriminations in delivering worker's needs and firing of a

worker colleague. Workers in units of packaging, PFC generator and technical education in the company participated in this complaining action. One participant worker said that general manager had promised to pay equal to one month of basic wages as a reward, but unfortunately only the certified workers receive it. As he continued, contracted workers only received something around \$200 that is contradictory to the promise made by the general manager.

It is important to remind that this morning, the representative of workers of this institution was stopped entering his job vicinity just because he was trying to find solutions to requests made by workers regarding removal of job and payment discrimination between formal and informal workers and the question of improving conditions of work, particularly considering the bad environmental conditions in the province of Khuzestan.

Strikes in oil and gas refineries has passed 22 days

Saturday August 22, contracting workers of oil and gas refineries and workers in generator facilities and cities continued their strikes after 21 days. These strikes have occurred in more than 55 centres, 24 cities and 22 provinces and every day new workers join to this cause. Two demands of increasing minimum wages to monthly 12 million tomans (\$US1200.00) and removal of middle contractors are vital.

The second new day of Hepco workers' protests gathering in the factory and under Bakhtiari Bridge for job and livelihood uncertainty after the lies told by the officials

Hepco workers told a media reporter about the non-payment of their wages in June and July of this year and part On Sunday, August 2, for the second day in a row, Hepco workers gathered in the factory and under the Bakhtiari Bridge near the railway to protest for the job and livelihood uncertainty and the lies told by the officials of the demands of 2016 and 2017: After months of playing games with the mind of the public and speculation that Hepco will be divested to Idro or Imidro, 55 percent of its non-management shares have been divested to the Social Security Adcomplex ministration.

Hepco workers added: The government has obliged the Social Security Administration to sell a surplus of 17% of its shares by the end of 2020; but at the same time, the situation of the workers is not clear and no one knows what will happen to us; while we are 760 people.

Hepco workers, referring to the fact that some of their colleagues were infected with the Corona virus, added: "Unfortunately, the management of the company has not thought seriously about

providing personal protective equipment at work, and the workers have to pay for it."



An unprecedented mass strike in the Iranian oil and gas sector is holding firm as it enters its fourth week

27 August, 2020 Around 10,000 workers in Iran's oil and gas fields have been taking part in wildcat strike action since 1 August. Despite attempts at repression, the strike is holding firm, morale among workers is high, and many employers are starting to offer concessions.

Although the industrial action is centred in the South Pars gas fields, the work stoppage has spread to industrial complexes in Mashhad, Tabriz, Urmia, Isfahan and other cities across Iran, affecting petrochemical plants, refineries and power stations.

The workers are employed by agencies that provide labour under contract to major oil and gas companies. These agencies are under tremendous pressure, as they are in danger of breaching their contracts with the oil companies. The dramatic shutdown of production is, in turn, a potential crisis for Iran, which is heavily reliant on the sector to generate foreign exchange.

Some contractors have conceded to the workers' demands to pay late wages and raise pay and have also agreed to pay wages on weekly basis. Workers' representatives have announced that the strike action will continue until all the demands are met, including for representation. The

demands include higher wages, secure contracts, and better accommodation and food.

Because independent unions cannot operate openly in Iran, the action is coordinated by an underground strike committee made up of workers. The Iranian government often blames industrial unrest on foreign agitators and exiled opposition groups and uses this as an excuse for heavy oppression by making it an issue of national security.



The strike committee has been able to resist oppression because it has focused on bread and butter issues. Workers have withdrawal their labour and maintained a dignified presence outside the employers' offices. The committee distributes weekly strike bulletins through social media, with updates and demands. The most recent bulletin acknowledges the support of IndustriALL affiliate, the Union of Mechanics and Metalworkers of Iran, for the workers' economic and social demands.

There is industrial action in other sectors as well. At the Haft Tappeh sugar refinery, workers have been on strike for 71 days, and IndustriALL's sister global unicomplex on, the IUF, wrote to the ILO to raise their concerns. The ILO responded to say that they had intervened with the Iranian authorities, urging them to ensure freedom of association and workers' right to defend their interests.

IndustriALL Global Union assistant general secretary Kemal Özkan said:

"IndustriALL expresses its full solidarity with Iranian workers. We admire your resilience and courage, because you don't have the luxury of being defended by free and independent unions. We fully support the demands of the workers for decent wages, paid on time, for direct contracts with the oil and gas companies, and for companies to negotiate with workers' representatives.

"Iran must recognize workers' representatives and independent unions as legitimate partners in negotiations."



IUF calls on ILO to help secure wage arrears for hungry sugar workers in Iran

10.08.20 **News**. The IUF has called for the urgent intervention of the ILO to help secure unpaid wages owed the 5,000 workers at the <u>Haft Tapeh sugar complex</u> in Shush, Iran. Workers last received their wages in March.

While the workers and their families go hungry, the owner is on trial in Tehran, accused of obtaining from the government some 1.4 billion U.S. dollars in scarce hard currency, ostensibly destined for investment in the company, and selling it on the open market at 3 times the price.

Since June, workers have been holding daily peaceful demonstrations at the governor's office in Shush to demand their wages. Work continues in the cane fields. There has been no factory production since June, but the workers are in limbo; the mill has not officially ceased production, although the gates are guarded by security.

Workers and family members have been infected with the corona virus which continues to spread while the government has officially Workers and their families have no access to health services as their social security contributions have not been paid by the employer.

The IUF has also warned of the real potential for state violence, particularly now that the Haft Tappeh workers have been joined by tens of thousands of <u>oil and gas workers on strike</u> over months of unpaid wages, among other issues.

In 2008, following a mass strike over months of unpaid wages, the workers formed a union which is affiliated to the IUF. Neither the employer nor the government has recognized the union, whose elected leaders have been imprisoned, dismissed and blacklisted.
